State Government Health Scheme SGHS

About the Scheme

- Running since 1st Jan 2021 vide G.O. dated 4th May 2020 further amended on 25th Nov 2021.
- Public / Private Hospitals (expertise / facilities available) are listed by the State Health Authority at the Central Government Health Scheme (CGHS) rates from the (SGHS) scheme.
- Medical treatment without any upper limit is provided to the Government Employees/ Pensioners and their dependants.

OPD Claims

- Out Door Patients (OPD) of SGHS beneficiaries and their dependents in empanelled/ non- empanelled clinics/ hospitals is done on reimbursement mode as per CGHS rates which includes Consultancy fee, Diagnostics / Radiology facility and medicines.
- The claims submitted by the beneficiaries will be verified at CGHS rates by the officer-in-charge of the district / sub-district hospital / the chief medical superintendent as the designated officer (countersigning officer) for this purpose. To whom the Head of the Office / Head of the Department / Administrative Department, as the case may be, within the limits of delegation of financial powers. The DDO will accept and forward the claim through IFMS Portal to the State Health Authority for payment.

- The original documents concerned will be preserved in the office of the Drawing Disbursing Officer (DDO).
- A certain percentage of medical claims will also be ensured to be audited.
- Non Admissibility – Cosmetic treatment/ products and non medical consumables.

Inpatient Medical Treatment (IPD)

- Inpatient cashless medical facility will be provided on admission in a private or public hospital empanelled by the State Health Authority.
- Reimbursement of medical expenses as per the rates of Central Government Health Scheme (CGHS) in case of employee/pensioners availing medical facilities in non empanelled hospitals. The claim will be submitted on the prescribed form / Mandatory certificate through their Head of Department / Administrative Department, as the case may be.

SGHS Beneficiaries – profile / eligibility

The scheme is on contributory basis on monthly deductions from salary/ pension at CGHS rates depending the level of employees/ pensioners as per 7th Pay Commission

level 1-5 : Rs. 250 pm; level 6 : Rs. 450 pm; level 7-11 : Rs. 650 pm level 12 : Rs. 1000 pm
